

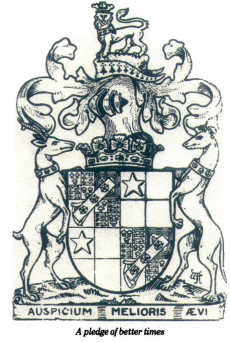
# Redbourne Parish Council Agenda
