1901 – Action Responses:

1901/05: Tree Stump grinding response: "I have been made aware that the parish wish for the stumps to be removed on the village green. We do intend to remove them this year but the staffing situation we have due to the winter rota schedule (gritting) means we can only deal with high priority work such as dangerous trees along the highway. This must remain until the end of March when the winter rota finishes."

1901/05: Speeding sign: "Roy Hindmarsh, who managed the speed management strategy, retired in November and his post is currently vacant. Various aspects of his work are being covered by other officers, however we have not been able to cover everything. One of those areas that has slipped is moving the flashing speed signs to the fourth quarter locations and I can only apologise for this.

Once we have recruited to the post things should get back on track. Although I'm not able to give a firm date I hope we are able to move the sign to Redbourne in April.

The latest speed monitoring on High Street, Redbourne was in September 2017. The results were as follows:

Total vehicles monitored = 18,995 - average of 2714 per day (9,221 northbound, 9,774 southbound)

Speed limit = 30mph

Mean speed = 32.2mph

85th percentile = 36.8mph - the speed at which 85% of vehicles are travelling at or below, which is a better indicator of the general speed of traffic.

Offending rate over 35mph (the speed at which the police will enforce following National Police Chief Council guidelines) = 24.84%, average 674 offenders per day - 479 per day travelling between 35mph-40mph, 153 between 40mph-45mph, 37 between 45mph-50mph, 6 between 50mph-55mph. Over the whole seven-day monitoring period 10 travelled between 55mph-60mph and 6 above 60mph.

North Lincolnshire has a speed management strategy that prioritises over 400 sites across the authority area based on the number of speed offenders, road casualties and several other factors including the potential conflict with other vehicles and vulnerable road users (e.g. cyclists and pedestrians) using the area. The speeds at all these sites have been monitored over a seven-day period to provide robust data. Unfortunately, resources are limited and as such we are only able to act at the first 120 sites on the priority list. The top 57 sites receive a programme of enforcement from the safety camera vans operated by Safer Roads Humber and the flashing vehicle activated speed signs for a three-month period. Sites 58

to 120 receive just the flashing vehicle activated speed signs for a three-month period. High Street, Redbourne currently appears at number 105 in the speed management strategy and therefore receives the flashing speed sign for a period of three months. My apologies once again for the sign not being erected in Redbourne as was originally planned."
