

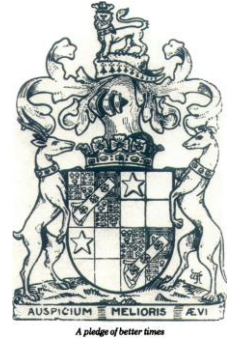
# Redbourne Parish Council Minutes

## Public Comment

- 1911/01**      **Apologies for absence**  
Apologies received from Philip Hotham, Pauline Hawley, Penny Stephenson and Cllr John England
- 1911/02**      **Declaration of Interest**  
Declarations received from JB & LW relating to item 1911/12
- 1911/03**      **Minutes of Previous meeting**  
Minutes of the Parish Council meeting held on September 2 duly signed as a true record
- 1911/04**      **Clerk's Report**  
Notice Board quote issued and deemed too high. Carried forward to next agenda with additional quotes to be sourced and shared prior to next meeting.  
Letters sent to local businesses requesting funds, a response has been received from Ongo that they are not for profit and don't issue grants. Merlin Renewables requested additional information. No additional responses received.  
Ward Councillor Poole stated that the current open grant application is likely to be reviewed in mid-November.  
Expected for the overhanging tress connecting Little Redbourne to the rest of the village to be checked later in November when work is being carried out in Kirton Lindsey. Photos to be taken and issued to NLC.  
Tree survey carried out by NLC and report received but difficulty in identifying which tree is which. Clerk to follow up with NLC and carry forward to next meeting
- 1911/05**      **Report from Ward Cllrs on NLC issues**  
Cllr Trevor England provided an update on British Steel who have gone through the due diligence process but no firm offers received from the initial Turkish interest. Still interest being received. Currently being funded by the Government until the sale goes through.  
Council tax scam doing the rounds, offering a refund of council tax, charging fees to "recover" overpaid amounts. Agreed to include on website.  
Current active planning application on the land of Day Farms, unknown if this will be on the planning committee in November. Ward Cllrs view is that the application is unsustainable and outside the development line so likely to be recommended for refusal.  
Flooding in Redbourne 26/10, concern over the beck running through Little Redbourne and concern there would be a repeat of previous flooding incident from 2007 which was as a result of lack of maintenance, heavy rain and blocked culverts. Assessment carried out and deemed that there will be three houses in Little Redbourne susceptible to flooding and therefore it is the responsibility of the homeowner to protect their houses. Possible other options are to create another dyke and to clear current landscaping blockages within the beck currently. Ward Cllr Poole to advise a work programme.  
Cllr Foster to follow up collapsed manhole cover which has still not been repaired.

Cycleway being set up from Brigg to Hibaldstow by Spring and then extended to include Redbourne along the Redbourne bank. Long term aim to include Brandy Wharf.

Fly tipping on private land will not be picked up by the council and will need to be resolved by the landowner.

a. Christmas Tree – Blacksmith has agreed we can use the electrics to plug the tree in and may be able to wire the lights into a timer. Plan to have a “Switch On” and budget for Christmas Tree and lights agreed at £200.00. Switch on December 12 at 1800. Best dressed Christmas Outfit switches on the lights.  
b. Winter Planting agreed to increase spend by £200.00

NorthLincs funding to be carried forward to January agenda  
Little Redbourne flooding concerns raised with Ward Councillor

a. Receipt of £60.00 for sale of trailer received in cash.  
Agreed payments of £25.00 to Lynn Wainwright and £32.93 for Judy Brown against planting fund.
